
# **Achieving success with Imprivata Identity Governance**

For each phase, we have developed criteria to assess where an organization is in terms of its operational status as well as governance status. At initial phases, the quality of operations and governance is considered low, and risk high. As organizations mature, the quality of their identity management processes improves, and risk decreases. Each phase also has a number of metrics, based on our experience with implementations, that can be used as a scorecard for an IAM or IGA team, internal stakeholders, or a C-suite audience looking for evidence of return on investment.

As an example, in the first "ad hoc" phase, an organization is really at the outset of a formal identity governance program. Here are some descriptors of the operation and governance status:

### Operation status

- · Siloed user and account management
- · Delayed, costly mistakes

### Governance status

- Disparate attestation campaign with poor success rates
- Low quality; high risk

Imprivata agrees with industry analysts and experts who advise on establishing a team and timeline, and starting small.
